What we do	
How does Bankers Life Securities, Inc. protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Bankers Life Securities, Inc. collect my personal information?	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> • open an account or seek financial advice about your investments • make deposits or withdrawals from your account • provide account information updates upon request from us or tell us about your investment or retirement portfolio <p>We may also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit sharing of your personal information only as follows:</p> <ul style="list-style-type: none"> • our sharing with our affiliates' for their everyday business purposes – applicable only to information about your creditworthiness • our sharing with our affiliates to market to you • our sharing with our nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	If you have a joint account, your choices will apply to everyone on your account, unless you tell us otherwise.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include financial services companies, including insurance organizations, registered investment advisers and financial holding companies.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

Other important information
<p>California, Montana, New Mexico, North Dakota and Vermont Residents:</p> <p>We will not share your personal information with affiliated or nonaffiliated companies for marketing purposes. You do not need to take any action to opt out of this kind of information sharing. We may share your personal information with affiliated or nonaffiliated companies to service your account, in accordance with and subject to applicable law, or otherwise to the extent required or permitted by applicable law.</p>
